SERVICES IN THE PROGRAM INCLUDE THE OPERATION OF A COMPETITIVE TRAVEL SOCCER LEAGUE FOR MEMBER CLUBS, SUPPORT FOR NONCOMPETITIVE RECREATION PROGRAMS, EDUCATION, BACKGROUND CHECKS ON VOLUNTEERS AND COACHING AND ADMINISTRATIVE SUPPORT FOR OVER 13,000 CHILDREN AND NUMEROUS VOLUNTEERS. REVENUE IS DERIVED FROM PER PLAYER REGISTRATION FEES PAID TO THE LEAGUE BY MEMBER CLUBS. THE COMPETITIONS ARE OPEN TO ALL MEMBER CLUBS AND OUTSIDE TEAMS AND ARE HELD ANNUALLY IN JANUARY AND JULY AT VARIOUS FIELD LOCATIONS. REVENUE IS COMPRISED OF REGISTRATION FEES PAID TO THE LEAGUE BY PARTICIPATING TEAMS.
